HHFA is now available at 70 hospitals in 20 cities throughout India, and an estimated 6,000 patients will receive treatment through the program in 2013.

Medtronic is also dedicated to conserving natural resources, promoting energy efficiency and eliminating waste. In 2013, the company concluded its first set of five-year environmental goals.
